- 7. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, Board of Directors, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Paragraph 3 hereof. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (Including the publishing or distributing of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by a Corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended.
- 8. All conditions, qualifications, requirements, privileges and regulations as to membership in the Corporation, including voting rights shall be fixed and governed by the By-laws of the Corporation.
- 9. Upon dissolution of the Corporation, the Directors shall, after paying or making provisions for the payment of all pliabilities of the Corporation, dispose of and transfer all of its assets to the Scranton Public Library, and if the said Scranton Public Library shall no longer be in existence, shall dispose of all of the assets of the Corporation exclusively for the purposes of the Corporation, in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, or literary purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954, or corresponding provisions of any subsequent federal tax laws, as the Directors shall determine.
